Sturbridge Woods Swim Club, Inc. was incorporated in 1990 to establish a community swim club. The Club's facilities, located on Forrest Hills Drive, Voorhees, New Jersey, are described in more detail below. The mailing address of the Club is P.O. Box 367, West Berlin, New Jersey 08091-0367.

DESCRIPTION OF FACILITY

The Club owns and operates a recreational swim club (the "Swim Club").

The Swim Club has two (2) swimming pools. The first is a six lane, twenty-five (25) meter pool of approximately 4,590 square feet, with a four hundred square foot wading area and a diving area with an attached one meter diving board. The second is a 15 foot diameter circular baby pool. Adjacent to the pool area is a 1,200 sq. ft. one-story building of block-type construction with separate enclosed changing, rest room and shower facilities for men and women. The Swim Club site contains an unpaved parking area for approximately 50 vehicles.

The operations of the Swim Club are under the direction of the Club's Board of Trustees. The following description of Club operations is subject to change from time to time, but illustrates the Club's activities in recent years. The Club's first year of operation was 1993.

The Swim Club pool and related facilities are generally open to use by the membership from approximately Memorial Day through Labor Day. Through June, the pool has been open weekends only; during July and August, the pool has been open seven days per week. The operating hours have been noon to 8:00 p.m. on weekdays, 11:30 a.m. to 7:30 p.m. on weekends. In the mornings, the pool has been limited to use by the Swim Club's swim team. The Swim Club does not operate between Labor Day and Memorial Day.

DESCRIPTION OF ASSOCIATE MEMBERS

You are purchasing a 2009 seasonal family membership. This membership is offered for the 2009 swim season, May 23rd, 2009 through September 7, 2009. Associate Members do not have voting rights and are not permanent members of the pool. This membership entitles you to full use of the swim club and registration for the swim team (normal registration fees apply). The cost of the 2009 Associate Family Membership is \$595 and a \$100 one-time initiation fee, for a total cost of \$695.
